

Kidz Gigantic Day Out is Adelaide's biggest and most exciting kids event. With four interactive zones, including science and nature play, sports, LEGO® and 'big rigz', Kidz Gigantic Day Out provides hours of entertainment for the whole family. To celebrate the countdown to Kidz Gigantic Day Out, we're inviting kids aged 15 years old or younger to join in our design competition. The major prize is a \$250 voucher to spend at Switched On Kids, Adelaide's top online store for interactive, educational toys for all ages ([www.switchedonkids.com.au](http://www.switchedonkids.com.au)).

Five finalists will each receive a family pass to attend Kidz Gigantic Day Out, 19–20 April 2019 at the Adelaide Convention Centre, where their works will be on public display.

Competition details are as follows:

1. Download one of the Minifig Design sheet templates.
2. The colouring competition is open to children aged 15 years old or younger who live in South Australia. Only one entry per child is accepted.
3. Complete your entry and submit as either a scan or digital photograph to [kidzdayout@avmc.com.au](mailto:kidzdayout@avmc.com.au). Entries close at 8pm ACST on Sunday, 31 March 2019.
4. The top 20 finalists will be shared on the Kidz Gigantic Day Out Facebook page ([www.facebook.com/kidzgiganticdayout](http://www.facebook.com/kidzgiganticdayout)) on Thursday, 4 April 2019, at which time a public vote will open to determine the top five finalists. The vote will be judged by the number of individual 'likes' each entry receives. Voting will close at 5pm on Thursday, 11 April 2019. The five entrants with the most "likes" will each receive a family pass to Kidz Gigantic Day Out.
5. The top five will then be put up for final judging by the Kidz Gigantic Day Out Team, with the winner to be announced on the main stage at Kidz Gigantic Day Out on Saturday, 20 April at 12noon ACST. One 1st Prize winner will receive a \$250 voucher from Switched On Kids; a 2nd Prize winner will receive a \$100 voucher and three Runners Up will each receive \$50 vouchers from Switched On Kids. The judges' decision will be final and no correspondence will be entered into.

# Kidz GIGANTIC Day Out

## MINIFIG DESIGN COMPETITION

### TERMS & CONDITIONS:

This competition is conducted by the Adelaide Venue Management Corporation (AVM) ABN 50 676 936 954, to promote the event Kidz Gigantic Day Out (KGDO), held at the Adelaide Convention Centre from 19-20 April 2019. Entry is open to children 15 years and under, who live in South Australia, with the approval of a parent or guardian. Proof of age may be requested. The competition commences at 12.00pm on Friday 8 March 2019 and closes at 8.00pm on Sunday 31 March 2019 (ACST). To enter the competition, entrants must complete and submit a completed Kidz Gigantic Day Out Minifig Design Competition form (artwork). Only one entry per child will be accepted. By submitting a completed artwork in to the draw, each entrant is deemed to have accepted these terms and conditions and consents to being contacted by AVM if he or she is drawn as the winner. Once submitted, the artwork will become the property of AVM and may be used for future promotional purposes.

The top 20 finalists will be selected by the KGDO organising team via a voting process. The top 20 finalists will have their completed artwork uploaded to the KGDO Facebook page ([www.facebook.com/kidzgiganticdayout](http://www.facebook.com/kidzgiganticdayout)) on Thursday 4 April 2019, at which time a public vote will be opened to determine the top 5 finalists. The vote will be counted by the number of individual 'likes' each entry receives. Voting will close at 5pm on Thursday 11 April 2019. The 5 entrants with the most "likes" will each receive 1 x Family Pass to KGDO (minor prize). The top 5 finalists' artwork will then be put up for final judging by senior AVM staff members. The 1st Place, 2nd Place and Runners Up (major prizes) will be announced on the main stage at 12pm on Saturday 20 April 2019 (ACST) at Kidz Gigantic Day Out at the Adelaide Convention Centre, North Terrace, Adelaide, SA 5000.

**Minor Prize:** The winners will be notified in person, by e-mail or via telephone within 1 business day of the winners being chosen. If the prize remains unclaimed by the winner for 1 day after notification, the prize will be forfeited. All decisions made by AVM are final and no correspondence will be entered into. The winners of the minor prizes will each receive 1 x Family Pass to Kidz Gigantic Day Out on either the Friday or Saturday of the event. The Prize is valued at RRP\$60.00. The prize is not redeemable for cash or transferable.

**Major Prize:** The winners will be notified in person, by e-mail or via telephone within 5 business days of the winner being chosen. If the prize remains unclaimed by the winner for 5 days after notification, the prize will be forfeited. All decisions made by AVM are final and no correspondence will be entered into.

The 1st Place winner will receive a voucher from Switched On Kids valued at \$250.00.

The 2nd Place winner will receive a voucher from Switched On Kids valued at \$100.00.

3 x Runners Up will receive a voucher from Switched On Kids valued at \$50.00 each.

Further terms and conditions relating to the use of the vouchers may be applicable, as set by the vendor Switched On Kids [www.switchedonkids.com.au](http://www.switchedonkids.com.au).
